

## ABSTRACT

Most foster children are not living with their fathers at the time they are removed from their homes. While in foster care these children may experience even less contact with their nonresident fathers. This study examined child welfare practices with respect to identifying, locating, and involving fathers of children in foster care including whether child support resources were used. Local agency caseworkers were interviewed by phone about nearly 2,000 foster children in four study states. The study found that nonresident fathers are not often involved in case planning and nearly half were never contacted by the child welfare agency.

The study was conducted in four states, Arizona, Massachusetts, Minnesota, and Tennessee, using three methods of data collection—interviews with child welfare administrators, case-level data collection through interviews with caseworkers, and data linkage between child welfare and child support systems. Of the three components, only the case-level data collected through interviews with caseworkers was contributed to the Archive. Investigators interviewed local agency caseworkers about particular cases between October 2004 and February 2005 to examine front-line practices related to nonresident fathers. Cases were selected from among children who had been in foster care for at least 3 months but no more than 36 months. Children in the sample were all in foster care for the first time (first placement episode), and the child welfare agency's records indicated that each of the children's biological fathers were alive but not living in the home from which the child was removed. Additionally, only one child per mother was eligible for the study.

Data on 1,958 eligible cases (83% response rate) were collected through telephone interviews with 1,222 caseworkers. The nonresident fathers of the children sampled represent a varied group. While most caseworkers, at the time of the interview, knew the identity of the fathers of children in the study's sample (88%), paternity had not yet been established for over one-third of the total sample's children (37%). A comparison with mothers found that demographic characteristics of identified nonresident fathers are similar to those of the resident mothers though fathers are slightly older (36 vs. 32 years old, on average) and more likely to have been married at some point. As expected, caseworkers appear to know less about nonresident fathers. The percent of "don't know" responses is much higher for nonresident fathers than for similar questions about resident mothers.

### Purpose of the Study

This study sought to examine how child welfare agencies identify, locate, and involve nonresident fathers of children in foster care in casework and permanency planning. The study also sought to determine the feasibility of using child support resources to aid in identifying and locating fathers of children in care. Specifically, the study was designed to:

- examine the extent to which child welfare agencies, through policies and practices, involve nonresident fathers of foster children in casework and permanency planning;
- describe the various methods used by local agencies to identify fathers of children in foster care, establish paternity, and locate nonresident fathers;
- identify challenges to involvement, including father characteristics that may be constraints and worker opinions;
- identify practices and initiatives that may increase father involvement; and

- explore how child support resources may assist child welfare agencies in identifying and locating nonresident fathers through case linkage.

### Study Design

This study is comprised of three components. Of the three components, only the case-level data collected through interviews with caseworkers was contributed to the Archive.

State child welfare information technology (IT) staff were provided with the sample selection criteria and used it to extract the universe of prospective cases to include in the study. Following the case selection process, interviews were conducted with local agency caseworkers, who managed at least two cases in the sample, between October 2004 and February 2005 to examine front-line practices on nonresident fathers. The interviews were conducted over the phone. The survey collected information from the caseworker about the following individuals: caseworker, foster children, nonresident fathers, and birth mothers. During the interview, caseworkers could request to exclude cases from the data linkage portion of the study which linked the child's case record with other state databases in an attempt to track down the non-custodial parent (see the project's final report for more information regarding the reasons why caseworker's excluded cases). After excluded cases were removed, state specific files were sent to the respective states where IT specialists merged identifying information. States then transferred the completed file directly to the state's child support agency. Child support IT staff added any child support information available in their automated system- paternity, child support order (attempted, established, collections), non-custodial parent located, state locator resources used/successful, and federal locator resources used/successful. Child support staff then de-identified the file and transferred the file back to study investigators.

The target population for the study includes all children in Arizona, Massachusetts, Minnesota, and Tennessee, who were in the custody of the state's child welfare agency at the time of sampling, and who had been in a foster family home between 3 and 36 months, were in foster care for the first time, and had a father who was alive, but did not reside with the child at the time of removal from the home.

### Date(s) of Data Collection

October 12, 2004 to February 4, 2005

### Geographic Area

Massachusetts, Tennessee, Arizona, and Minnesota

### Unit of Observation

The units of observation are the child and the caseworker. Child file records correspond to individual children and caseworker records correspond with individual caseworkers.

### Sample

State child welfare information technology (IT) staff selected cases using the following, investigator provided, criteria:

- Children were in foster care for at least 3 months but no more than 36 months.
- Children were in foster care for the first time (first placement episode)
- Only one child per mother was eligible for the study
- Biological fathers were alive but not living in the home from which the child was removed (referred to as "nonresident fathers").

Once the state extracted the universe of cases that met the above criteria, the study statistician developed the state sampling designs. In each state a two-stage design was developed. In the first stage, caseworkers managing at least two cases meeting the criteria were identified. Caseworkers managing only one case meeting the criteria were eliminated (There are a few state specific exceptions to this "rule." See the project's final report for more information). All of the children managed by the first-stage caseworkers constituted the second-stage sampling frame. Two children were selected randomly from each sampled caseworker. A total of 1,958 cases were deemed to have met all inclusion criteria. These cases make up the "Child" file. Demographic information for the foster cases used in the study can be found in Table 1(unweighted). A survey weight is needed in order to generate representative estimates of children who are in foster care and have a living non-custodial father. A sampling weight was constructed that made it so that each sampled child represented the proper proportion of children in the sampling frame. The final child weight (labeled as "weight" in the data file) is set equal to the sampling weight but then is further adjusted to account for the expanded frame (control total), ineligibility, and nonresponse.

Caseworkers managing the selected cases were asked to participate in a phone interview. The interview was designed to collect case level information about the randomly selected cases. The total number of caseworkers interviewed was 1,222. Demographically, the sample is similar to child welfare workers nationwide. Survey respondents were slightly more likely to be female (81% vs. 72%) than workers overall. Respondents had one more year of experience than the general population of social workers in public child welfare agencies (8 years vs. 7 years). The racial breakdown of caseworkers is somewhat diverse with a fairly large group of African American caseworkers (20%). However, ethnicity is less diverse, only 8 percent of workers noted they were of Hispanic origin. Table 2 shows a breakdown of caseworker race by gender. Please see Table 3-1 in the project's final report for a more complete breakdown of caseworker demographics.

## Analytic Considerations

Missing data: Each question has a separate code for Don't know or refused - if the question was not asked the variable value is left blank and thus treated as a system missing value.

## IMPORTANT INFORMATION REGARDING THE CONSTRUCTION AND USE OF THE SURVEY WEIGHT:

### Calculation of Final Child Weight.

A survey weight is needed in order to generate representative estimates of children who are in foster care and have a living non-custodial father. A sampling weight was constructed for each record in the original state sample files. The sampling weight is the number of children in the sampling frame that each sampled child represents. The final child weight is set equal to the sampling weight but then is further adjusted to account for the expanded frame (control total), ineligibility, and nonresponse.

Expanded Frame Adjustment: With the exception of MN, the sampling frame excluded the children managed by caseworkers who managed only one child. The purpose of the exclusion is to increase efficiency at the expense of minor undercoverage. The expanded frame is the resulting frame after these children are added to the sampling frame. Therefore, the size of the expanded frame represents the size of the target population per county. The child weight was adjusted for the difference between the sampling frame and the expanded frame. The adjustment for the expanded frame is actually the adjustment for frame undercoverage.

Ineligibility Adjustment: Some sampled children are ineligible (out-of-scope) for this study. So the child weight was further adjusted based on a State's regional ineligibility rate.

Nonresponse Adjustment: Some sampled children are eligible (i.e., within the study scope) but could not be interviewed for various reasons. So the child weight was further adjusted based on a State's regional nonresponse rate. This adjustment assumes missing at random.

The above adjustments are through post stratification. The sample and the expanded frame are post stratified into weight adjustment cells and the weight is further adjusted for ineligibility and nonresponse within each cell. For each state, the adjustment cells are defined by grouping some geographical locations into weight adjustment cells.

#### USERS OF THE DATA SHOULD BE AWARE OF THE FOLLOWING TWO ISSUES WHEN WORKING WITH THESE DATA:

**ISSUE 1 :** Children who have been reunited with the mother or placed with the father at the time of the interview.

The survey instrument does not accommodate children who had been reunited with their mothers or placed with their fathers at the time of data collection. To contend with this problem UI and NORC designed a job aid to help interviewers circumvent the problem. Interviewers were given the following instructions to follow when encountering either of these situations.

When an interviewer was told that the child had been reunited with his/her mother or placed with his/her father, question C8D “Is the child currently living in some other placement option?” was answered “yes” and a verbatim description of the reunification or placement option was entered. Because questions D34, D35, D36, D37, D38A, D38B, and D38C would be awkward to ask about children placed with fathers and questions E34, E35, E36, E37, E38A, E38B, and E38C would be awkward to ask about children reunited with mothers, interviewers were instructed to enter a “Don’t know” response to these questions without reading them to the caseworker. Cases where the child was reunified with the mother or placed with the father can be identified by these characteristics.

**ISSUE 2:** Cases where the child’s father died more than 6 months ago, but the child still meets case eligibility requirements.

A minor skip pattern error was noted during data collection in eligible cases where the child’s father had died more than six months ago. In this situation the questionnaire would route the interviewer through questions asking about the father’s visitation within the past six months. Because the father had been deceased for the past six months or more, asking these questions would be awkward. To accommodate this issue and not confuse the caseworker, interviewers were instructed to enter a “Don’t know” response at questions D35, D36, and D37 without reading them to the caseworker. Examining the responses to variables B12, B13, D35, D36, and D37 will tell the researcher if the child’s father died within the six months prior to the interview.

#### Confidentiality Protection

Primary identifiers were removed from the data files by the investigators prior to archiving.

Specific variable changes:

- Deleted Variable B14G – not useful after eliminating ineligible children
- Calculated child’s age (top coded at 18+) then deleted variables (B2, B2A, B2B, B2C)
- Calculated by quarter the time when father’s parental rights was terminated and bottom coded lowest value equal to or prior to 2003, then deleted variables (D38A, D38B, D38C)
- Calculated father’s age (bottom code less than 18 and top code 55+) then deleted variables (D6, D6A,

D6B, D6D)

- Recoded Father's education (D8) into 4 groups (1-2=1), (3=2), (4-6=3), (7-9=4)
- Calculated by quarter the time when mother's parental rights was terminated and bottom coded lowest value equal to or prior to 2003 then deleted variables (E38A, E38B, E38C)
- Calculate mother's age (bottom code less than 18 and top code 50+) then deleted variables (E4, E4A, E4B, E4D)
- Recoded mother's education (E6) into 4 groups (1-2=1), (3=2), (4-6=3), (7-9=4) Open-ended responses in both the child and caseworker files were partially cleaned by so as to avoid any disclosure problems (names, places and other identifying information).

### Extent of Collection

This data collection consists of the User's Guide and Codebook, the project's Final Report, NORC's methodology document, the survey questionnaire, and two text data files with data import statements for SAS and SPSS, and two Stata native files.

### Extent of Processing

NDACAN produced the User's Guide and Codebook, text data files, data import statements for SAS and SPSS, and the Stata native files.

### Data File Notes

Definitions for abbreviations used in the documentation and data file:

National Opinion Research Center (NORC)- research organization contracted by the Urban Institute to conduct the caseworker phone interview.

There are two separate public use data files; a child data file, which contains the data collected for the 1,958 eligible children; and a caseworker data file that contains information about the 1,222 caseworkers who completed the questionnaire and thus provided the information about the children.

**NORC's Public Use Data File Notes:**

The following modifications were made to the original delivered data files in order to produce the public use files.

The Caseworker public use file had no significant changes from the data file prepared by NORC. The only change to the caseworker file was the addition of the state variable from the crosswalk file.

The Child public use file differs from the NORC delivered data file in the following ways: All children who were found during the survey to be ineligible were removed from the file. Besides reducing potential risk of being able to identify these children there really was no advantage to keeping these children on the public use file. They cannot be included in any analysis since it is not known whether or not they were sampled by mistake or through agency inability to determine the father's status during the selection.

The caseworker id, final child weight, and the State variable were added to the file thus eliminating the need for producing a crosswalk file. Caseworker information can easily be merged onto the child file using the caseworker id variable.
